MINUTES

Minutes from City Council Special Meeting – June 28, 2022

Councilor Pierson made a motion to adopt the minutes from the City Council Special Meeting held on June 29, 2022 as presented; Councilor Williams seconded the motion.

PUBLIC COMMENT

Mike Hughes – Fire Chief for City of Boardman

Mr. Hughes asked to speak regarding the push back his department is receiving from the Morrow County Health District, and thanked Mayor Keefer for standing up for the process of allowing the Fire Department to respond to medical aid calls in their jurisdiction.

Mr. Tallman also thanked the Mayor for assisting the Fire Department as his father had recently required assistance. Mr. Tallman continued to ask the city to work together and also asked the city for transparency. He said he knows one of the councilors had moved to Pendleton, and asked the councilors to do the right thing.

ACTION ITEM

Procedure to Hire a New City Manager

Mayor Keefer read a prepared statement into the record addressing the citizens of Boardman. Mayor Keefer stated he wished to express he felt the City Council has followed all processes required, and stated he felt the City Manager and the Assistant City Manager acted with integrity and ethically throughout this process.

Councilor Pierson introduced Sharon Harris from CIS and asked her to provide some tools and guidance for the councilors to use as a guide through this hiring process. Ms. Harris advised the council that this is a collaborative process, and is one of the most important decisions that is made by a city council, and made clear her advice is coaching and not legal advice. Ms. Harris outlined the steps needed for recruitment; a current and clean job description, an outline of the process and timeline, she explained veteran's preference law, advised council to seed advice from the city attorney, and explained that an

outline for a recruitment process would be helpful. Ms. Harris also recommended the councilors refer to minutes taken in the past for direction in this process, and to see what council has already agreed to and to review to see if they have met those agreements.

Councilors discussed past intent versus direction, and then asked several questions to decide if their previous actions in recruitment were acceptable. Councilors then moved discussion toward internal versus external applicants and the benefits of recruiting in house versus using a recruitment agency.

Councilor Drago made a motion to open applications for internal and external candidates without outside sources for preliminary recruitment. Mayor Keefer seconded the motion.

Councilors then discussed what procedures or next steps they should decide on before the vote; Mayor Keefer stated councilors should vote and not put the cart before the horse as those steps can be decided on later.

The motion passed 5-0 with two councilors absent.
