## 2021-2022 - Supplemental Budget Hearing

Council President Drago announced the reason for the public hearing was for the adoption of the supplemental city budget for 2021-2022. There will be a three-minute limit on speaking times unless otherwise needed. He asked if there were any Abstentions or Objections to Jurisdiction; there were none. Council President Drago asked Finance Director Barajas to give the staff report.

Finance Director Barajas stated the city had anticipated paying the majority of the fees for the Boardman Migrant Head Start, which is through a Community Development Block Grant (CDBG), today. Due to staffing changes at the state level and the time they require to process and release the funds, the city will not receive the funds until next week. This is adding those additional funds to be received and will be expensed in this coming fiscal year.

Council President Drago asked if there were any Proponents, Opponents, Cross Examination, or Public Agencies who would like to be heard; there were none.

Council President Drago closed the public hearing at 7:04pm. Council President Drago reconvened the special meeting at 7:04pm.

## Resolution 11-2021 - 2021-2022 Supplemental Budget Resolution

Councilor Profitt motioned to approve Resolution 11-2021, a resolution to adopt the supplemental city budget for fiscal year 2021-2022 in the amount of \$1,594,285. Councilor Williams second the motion. Council President Drago asked if there was any discussion needed. Councilor Beagle wanted to clarify all funds would be grant funds and not from the community. Finance Director explained all funds are from the CDBG. She explained the council had already approved the \$230,000 in the original budget and this resolution is increasing it by \$1,364,285.
